Protecting family, yourself and your property will be your first thoughts when a hurricane warning is issued, but remember it is also important to protect your financial interests and be financially prepared!

- ✓ CASH & CHECKBOOK » Make sure to have cash on hand before a hurricane strikes
 - ✓ ATMs may not work after a storm
 - ✓ Businesses may not be able to process credit & debit cards
- ✓ ACCOUNT NUMBERS » Write down credit union and credit card account numbers as well as the address & telephone numbers
- ✓ IMPORTANT PAPERS » Gather insurance policies, birth, wedding & death certificates, your last pay check stub and other difficult papers to replace
 - ✓ Make sure to take them with you when evacuating and keep them in a safe place, such as a waterproof container or safe deposit box
- ✓ SHARED BRANCHING » You can access your accounts at one of the many Shared Branching outlets or service centers located across the country
